We continue to make progress on opening the Savage River Trail System, and have been working hard with western civic and social leaders espousing the gospel of OHV recreational tourism. ### Savage River State Forest OHV Trail & NOHVCC Workshop for DNR

It has been many years in the making and members of your Alliance Board have been working on this long before the Alliance was formed. Last year the State officially started the process to create an OHV trail system within Savage River State Forest. The initial

engineering assessment was completed and the Alliance was invited to review the proposed trail layout. To put it mildly, we were underwhelmed. Fortunately we saw this coming and had been working with the National Off-Highway Vehicle Conservation Council (NOHVCC) to conduct a 2-day workshop (at no cost to DNR) on trail design and maintenance.

We used your donations and split the cost with NOHVCC to conduct the workshop. It was money very, very well spent. NOHVCC sent one of their senior project managers, Jack Terrell, as well as Ron Potter who recently retired from the Minnesota Department of Natural Resource. Ron spent 37 years as the MN DNR Recreation Systems Manager in the Parks & Trails Division. He is a nationally respected public trails manager and was very, very well received by the MD DNR members who attended. DNR sent two senior leaders and about 20 other employees who ranged from headquarters level planners to local land managers. The workshop was one-day of classroom followed by a day in the field. It was amazing and exciting to see their eyes opened by Jack and Ron over the two days of the workshop. We should also add that when we went to the field, the engineering firm DNR hired accompanied us.

By the end of the workshop, the original plan was totally scrapped and DNR proposed a dual-trail system paralleling the 7-miles of Red Dog Road with interconnecting loops. We went for 5-6 miles of trails to 30+ miles of trails and from 15 users per day to 30 users per day. We believe that a well-designed trail monitoring system will show DNR that even more users per day can be achieved. This is a great start and will be a model for future OHV areas on public land.

DNR expects all the work to open the trail system to be completed by the end of 2015. You can be assured we will stay closely involved with DNR to ensure that happens!

### **Trail System Monitoring Initiative**

Your Alliance was the instigator to start a trail monitoring working group with representatives from the Maryland DNR (Wade Dorsey, Savage River Land Manager), Garrett College (Kevin Dodge), Garrett Trails (Steve Storch) and the MD OHV Alliance (Ken Kyler). Steve has a PHD in Outdoor recreation Management and has done a lot of work on trail monitoring programs that is directly applicable to creating an OHV trail monitoring program. DNR has found seed money to fund some Garrett College

Wilderness areas. Restricts use of current OHV trails and eliminates portions of existing roads each year. What does this mean? Less access to our public lands. This is a growing epidemic within our national and state forests. There is a planned appeal of the Plan set forth for the GWNF. You can access and read the final plan at <http://www.fs.fed.us/r8/gwj>. These same type of actions are happening all over the country.

I hope none of us are following the example of the goons in that reality show but are responsible when on the trails and are involved in contacting our elected public officials when there is a proposed action to limit or close access to our public lands.

See you on the trails. Those that are left. Be safe.

students to do the monitoring under the supervision of Kevin.

You may ask why we should embrace trail monitoring.

Trail monitoring is a proactive way to ensure trails are sustainable and thereby remain open! Green Ridge had no trail monitoring program and was shut down with little warning as an unsustainable trail. We view a well designed trail monitoring program as a defensive measure as well. By being proactive, we can bring volunteers to the trail and mitigate issues before they become problems—something we should have done at Green Ridge. Also, because Maryland manages all forests as “sustainable forests” a monitoring program is vital to their next evaluation. By being proactive and mitigating issues as they arise we can show that OHV recreation is compatible with sustainable forests.

**Economic Benefit Meeting with Western Leaders**

The Alliance had a social meeting with Senator Edwards, elected state and county leaders, as well as landowners and significant social leaders to continue last year’s discussions on the economic benefits of OHVs to the counties. This time we presented the economic impact that surrounding areas experience from OHV recreational tourism. The attendees seemed quite surprised by the economic benefit the counties could experience. This is a very slow process but we are making inroads. One result was an invitation to meet with Mike Koch who is the executive director of Garrett County’s Department of Planning and Economic Development. Mike thinks OHV recreational tourism can only be good for the county if done right. Our job is to show him it can be.

**Future Initiatives**

Your Alliance will continue to push forward on the issues above as well as undertake new initiatives.

New State leadership!

The election of Larry Hogan has changed the world and created vast opportunities for us. We believe Governor-elect Hogan will be a strong supporter of building OHV recreational tourism using State land as well as public/private partnerships. It appears that Hogan will appoint Charlie Evans Jr. (who worked as the assistant secretary at DNR during the Ehrlich administration) as the next DNR Secretary. We will be working to get on his calendar and discuss OHV recreation on DNR lands and we will push to reopen Green Ridge State Forest.

Updating Maryland’s Outdated OHV Noise Legislation

Maryland’s legislation on OHV noise is woefully outdated. With the help of AMA, we are drafting an update to use the Motorcycle Industry Council (MIC) and AMA’s recommended noise standard and testing

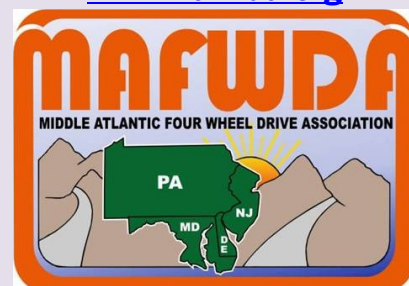

method. It will also address spark arrestors. We are drafting language to ensure this only applies to OHV use on public property and may be waived for races or events. We all follow these standards already so this won't be any change for you. This is primarily a defensive move on our part. We would rather have standards passed that we all already adhere to versus having someone with an axe to grind push through a very onerous law. Noise is a major issue and has contributed to closing OHV parks and other riding areas.

### Summary

Your Alliance will be pushing hard on the issues above. We are achieving results many long-time Marylanders though impossible. This is all because of your strong support. We are a tax-deductible 501(c)(3) organization and we have been achieving great results with your funds! ❖

Several members of CORE participated in a volunteer weekend at Green Ridge State Forest (GRSF). Larry arranged a work project with GRSF Manager Mark Beals. Our project for this weekend was left up to the Forest Service crew; we did not find out the assignment until Saturday morning.

I arrived at Group Site 1 at approximately 2:30 on Friday afternoon. Larry was already set up and was out and about looking for a stake for his canopy. It

was a nice warm, sunny afternoon around 60 degrees and the bugs were out in force! I started to erect the "Taj Mahal" and after ingesting a couple of gnats it was time for some OFF DEEP WOODS spray. Five minutes after I finished with the tent, Larry arrived back at the camp site.



If you don't know, GRSF has only primitive camping, no water, no shelters and no toilet facilities, but the group sites have a porta-potty. Well, guess what? Ours was locked and the park personnel gave Larry the explanation "we changed suppliers and they are the only ones who have keys to unlock and we forgot to call them". Larry had bought 2 bundles of fire wood from the Exxon station (all they had) and I had 3 bundles left over from the spring volunteer weekend. Kevin advised Larry that he was bringing firewood. Hopefully we would have enough for Friday night. We finished setting up my canopy over the picnic table and put on the sides to protect us from the wind.

Robert, who lives in Parkersburg, WV, arrived after his 3 ½ hour drive around 5:00 pm. Since everything was set up all he had to do was his cot!

Kevin and his crew (wife and kids) arrived before dark. After setting up his trailer and canopy, he unloaded the wood that he brought. It should be enough for Friday night and Saturday morning!

Serguei and his son, Sabastian, arrived next and...he brought 3 bundles of wood! It did not take long for him to set up as they were sleeping in their Jeep.

Last to arrive was Andrew and Cherie along with Steve and Lauri. Usually their gear is contained in the back of the Xterra, with the extra people, Andrew was towing a trailer! Luckily Andrew brought his porta potty and it was erected next to the locked one. After setting up their tents it was time for dinner. We entertained ourselves around the campfire Friday evening. It was not too cold and the fire was nice.



As anyone who camps knows, you do not sleep late as there are no curtains to close to keep the light out! We started a small fire and everyone had breakfast. About 9:00 am the Forest Service crew arrived and we discussed our work assignment. We were going to clear brush along the access road to campsite 46. We "loaded up and moved em out" and our caravan was on the way at 9:30 am.

Campsite 46 is one of the secluded ones, down an access road and hidden from view. When we arrived, we traveled down the access road to the campsite. A Toyota 4runner and several people were at the campsite. They were happy to see us! Seems like someone either left the lights on in the vehicle or plugged in too many electronics...the result was a discharged battery. The Forest Service crew gave them a boost and they were on their way. One side of the access road had light trees and saplings to the edge of the road and the other was not as badly overgrown. We trimmed back both sides of the road, dragging the brush into "holes" in the tree line wherever we could. The excess we piled into the empty areas around the campsite, but not on the campsite proper. We finished the clearing in a little over an hour due the tremendous turn out of volunteers (13). We headed back to Group Site1 for an early lunch and then for a trail ride.



After lunch we hit the trail. There are no longer any actual "off road" trails located in GRSF but there are plenty of dirt roads and some can be fairly rough (there is even one with a sign that reads "4X4 only"). Yes, I know, it is not an off road trail; however, it is not pavement either. We did a 63 mile ride, Seruei had an app on his phone which plotted our route (<http://gps.motionx.com/maps/78de97790a1fa6f3e67c201b725a3a0c>).

After our "trail" ride we went to the Exxon station to

## Can "Multiple-Users" Rule the World?

I'm so tired of the vocal minority (with money) influencing my public lands that I could puke! I say it's time for multiple-use to rule the world! (g). By that I mean, it's time that we take back control of how land use decisions are made in this country. It's time for recreation and multiple-use to rule!

How do we go about that? How do we get after-market manufacturers, RV groups and industry, motorized recreationists, equestrians, mountain bikers, AARP members, SUV drivers, hunters, etc. all rowing in the same boat so we control the boat? Well, it's a big order; but we can do it.

Do you have any idea how large our numbers would be if we were standing side by side with everyone who tows a SUV behind their motorhome; everyone who has a four wheel drive; everyone who snowmobiles; everyone who like to ride horses or dirt bikes or mountain bikes; everyone who buys after-market products for their toys; everyone who plays on a personal watercraft; everyone who makes a living off of public lands; and so on and so on??? HUGE! We would literally rule the world because that would be the majority of Americans.

Unity; united front; cohesive effort; banding together; and being on the same side, are all ways to say the same thing. In order to achieve such unity, we must learn the first step: SHARE. Within our own ranks, we must learn to share the trails; share the public lands; share our opportunities with others to increase understanding and tolerance. There's an old saying: "Seek first to understand; then be understood." By learning to share with others, we learn their needs and they ours. Once we can see how another use of public lands fits with ours, we can develop a way to share those public lands to the benefit of all.

There will be times when uses of public lands conflict with each other. That's normal. But here is where we must help our public land managers develop a plan to accommodate the many uses and minimize the conflict. We all need to be a part of this process. We also need to be presenting a unified front while doing so. If I am a dirt biker, then I should help my local public land manager develop a trail system that accommodates both my needs and those of hikers and equestrians. Some trails we can share; some we should set aside for single use or limited use. But I should be right there helping to develop that plan.

If I am a four-wheel drive person who likes to snow-wheel, then I should help my local public land manager develop a trail system that accommodates both my needs and those of snowmobilers and cross-country skiers. We need to work together in order to fully and effectively share the trails while providing great experiences for all users.

The same thing is true for those who make a living off the public lands. Timber harvesting, mining, grazing and other uses are legitimate uses of public lands in many places. We should be seeking ways to help public land managers find opportunities to allow legitimate use of our lands, while still accommodating the needs of recreationists.

Can you see why so many public land managers feel a bit helpless at times? What an overwhelming task they face! And the reason many of them are frustrated (and our land designations get so screwed up) is that WE'RE NOT IN THERE HELPING THEM!

We OWN public land. It's ours. It's our right to recreate, make a living, walk peacefully, ride a horse, sled in the snow, crawl over the rocks, whatever. But public land managers can no longer do it without us. You must be part of the solution. We need to educate our elected officials also. It's the same old story; but this time, the ending can be influenced by us. Sharing trails is one big solution to a national problem.

You can read all the demographic studies you want; and the bottom line is there's more of us (people) than ever before and there's a lot more to come. Besides an expanding population base, more of us are "taking

BURNSIDE - Staff at the Anthracite Outdoor Adventure Area (AOAA) has a new set of wheels.

At Monday's meeting the AOAA authority accepted a proposal from Schreffler Equipment Inc., of Pitman, to purchase a 2015 Polaris Ranger XP 900 EPS for \$15,292 plus title fee.

The purchase is conditioned upon final approval from the Department of Conservation and Natural Resources, which is helping to fund the new equipment through a grant.

The side by side will be used to assist with a variety of manpower tasks, such as improving trails. Authority members made the selection based on the features available on the machine as well as price.

After a motion had been made to approve the purchase, authority member Pat Mack pointed out an additional benefit of choosing Schreffler Equipment as the supplier.

"Here's another example of helping out a local business," he said.

The authority also voted to advertise a request for qualifications and pricing from surveyors for projects regarding AOAA boundary lines and surveying needs in 2015.
