We all live on the north side of town in Maryland, so we were able to easily meet up just off the Connecticut Ave. exit of the Beltway. The trip took a little longer than the 2.5 hours my GPS due to construction on 66. The ride is quite straightforward and very beautiful, especially on a sunny fall day. It's just straight out 66 to 81. South on 81 to WV55 and then another 40 miles into the mountains. You do want to gas up before you get too far into the mountains. The park is located at 39°11'35"N, 79°0'37"W.

These trails made me feel like I was getting some very good practice driving under different situations and becoming a better off road driver because of it.

The park is still being developed. The owner John Bradshaw met us and agreed to be our trail guide for the afternoon. John was great. Like I mentioned earlier, this is not the biggest park I've ever been to. John probably has no more than 10 miles of trail in total. The trails are very good and different from what we usually drive. They cut back and forth across the mountain. There was no dirt road driving, except the driveway into the park. There are trails at all levels of difficulty from green to red.



There is a lot of bush driving. You really feel like you're in the deep woods, not on a groomed trail, although the trails are probably the best marked that I've ever driven. They even indicate how the trail might differ under different weather conditions, e.g., green when dry, blue when wet. There is not a lot of rock crawling at this park. The mountain trails put you in some tough off camber situations. Nothing too scary or likely to hurt your rig other than some pin stripes, but situations where you really have to concentrate on your driving skills. These trails made me feel like I was getting some very good practice driving under different situations and becoming a better off road driver because of it.

There is also an area that has been set aside with obstacles and water hazards. It's not like the big mound at Rausch Creek where people pull up at wild angles

for a photo op. This is more a training area. A fun training area, but definitely designed to help you improve your driving skills. There is a very nice camping area with toilets and water. Very nice meadow to camp in with fire pits and picnic tables.

Overall, all of us were impressed and had a great time. John Bradshaw was great and willing to help anyway he could to make it a day to remember. We would all go back again and would strongly suggest that CORE consider Twin Mountain for a large group in the future.❖

2015 Maryland Off-Highway Vehicle Alliance Year in Review

Our third year just gets better! Again it was all due to your help, donations and a strong Board of Directors. We continue to make progress on opening the Savage River Trail System, we have continued to work with western civic and social leaders espousing the gospel of OHV recreational tourism, and we have established a strong working relationship with the new DNR administration! It was quite a year and you made it happen with your generous support! As Paul Harvey would have said, now for the rest of the story!

Partnership with DNR

On July 20th, we met with Mark J. Belton, Secretary of Natural Resources, and the newly appointed Assistant Secretary for Land Resources, Darryl Anthony. We had a very positive meeting with the Secretary and Assistant Secretary. We focused on OHV recreational tourism and the economic benefit to rural counties, and public/private partnerships using reclaimed coal mines. We specifically asked him to ensure that the Savage River trail opens next year. Our community has waited almost 5 years for the promised establishment of a public OHV area and it is time to deliver. We also briefed him on the need to have a certified trail builder assist with the trail layout. Construction of sustainable and safe trails is not a job that anyone can do. The State needs to get this right the first time. He promised to engage other departments and remove roadblocks as well as push to ensure a trail builder is part of the construction team. The DNR has been looking at 3,000 acres near Kitzmiller, MD. We have been discussing this with DNR and western Maryland leaders for several years. We asked him to purchase the property and ensure it is operated as an OHV park. This could be the southern anchor to a joint public private riding area similar to Hatfield-McCoy. The Savage River trail

would be the northern anchor. In that regard, we asked Secretary Bolton to engage with the Department for Economic and Business Development to request a Joint DNR/DBED working group to look at OHV recreational tourism state-wide.

It gets better!

On October 23rd, we had a follow-up meeting with Daryl Anthony, Assistant Secretary for Land Resources. In this capacity, he is responsible for Engineering and Construction, Maryland Environmental Trust, Forest Service, Land Acquisition and Planning, Wildlife and Heritage, Maryland Environmental Trust, and the Maryland Park Service. For such a busy man, I was surprised and pleased that he gave me nearly 2-hours of his time. I should add we spent a good portion of that time discussing his awesome Jeep Rubicon and some of his wheeling adventures! Asst Sec Anthony is definitely an off-road guy!

Early on in our conversation Daryl stated that DNR recognizes OHV/ORV use as a viable recreational opportunity and DNR will provide opportunities for this use. The rest of the conversation supported that. I have no doubt that he is committed to opening and maintaining OHV riding areas on State land.

Much of our conversation regarded the Savage River trail systems. He stated frequently that DNR must ensure that it is done right the first time. He shares our concerns that without heavy involvement from the end user group, DNR is at risk of building a trail system no one wants or would use. As a wheeler, he is personally vested opening Savage River for OHV use.

Economic Benefit Meeting with Western Leaders

We have continued to meet with civic and political leaders in Allegheny and Garrett Counties. This is a slow process to build support but we are making excellent progress. The new Garrett County Commissioners are very interested in the economic benefits of OHV recreation tourism -- that in itself is a big win on our part.

We met with the mayors of Barton, Midland,

Jenn was heard to say that "...this had to be one of the hardest black trails for a long time...". The only carnage mentioned was Jenn's nonfunctional rear locker and her damaged motor mount. The trails at AOAA are a little harder than at Rausch Creek, for example a blue rated trail at AOAA is more akin to a blue/black at Rausch Creek. The trails are different than Rausch Creek, some likened them to the trails at Paragon.

12/12 - Christmas trail ride (club sponsored) at Rausch Creek

10 members and numerous family members attended this club sponsored trail ride on a balmy 61F day in December(?) The group started off together and travelled to the Fire Pit, where half the group, led by Noel, went off to tackle the black trails at the back of the Fire Pit. Republicans' Big Stand for Hunters

Congressional Republicans are trying to make it easier for hunters and fishermen to bag a deer or hook a trout on federal land.

They are pushing legislation that would give people more access to land owned by the government, an issue that drove a group of militants last week to occupy a building in a federal wildlife refuge in eastern Oregon. The bill would also allow hunting, fishing and sportshooting on federal lands unless the managing agency bans those activities.

Sen. Lisa Murkowski, R-Alaska, is hoping the third time is the charm for the Sportsmen's Act, a bill she introduced in February that cleared the Senate Energy and Natural Resources Committee in November. It has been introduced twice but has failed to make it through Congress due to various political side disputes.

The bill brings together a number of disparate concerns for outdoor enthusiasts under one piece of legislation, but the heart of it is improving access to

U.S. Forest Service and Bureau of Land Management lands. Murkowski said the biggest provision is what she's calling "open unless closed," which dictates that federal lands are open to the public unless the Forest Service or Bureau of Land Management has a reason to close them.

Murkowski said the federal government too often closes off its land temporarily for no real reason or closes it with an eye toward permanent closure. Her legislation would end that practice, she said.

"As a result, our sportsmen and sportswomen will have increased access to public lands," she said in a floor speech last month.

Access to federal land became a national issue after a group of militants seized the headquarters of the Malheur National Wildlife Refuge in eastern Oregon. The group, led by the sons of Nevada rancher Cliven Bundy, who engaged federal authorities in a high profile standoff in 2014, opposes the federal control of large swaths of the West.

The federal government owns huge portions of most Western states. It owns more than 60 percent of Alaska, 45 percent of California, 36 percent of Colorado, 61 percent of Idaho, 85 percent of Nevada, 53 percent of Oregon, 48 percent of Wyoming and almost 65 percent of Utah, according to the Congressional Research Service.

The bill would allow states to manage some of the federally owned lands and would set new guidelines for federal purchases of land. While the anti-government extremists do not recognize the authority of the federal government on the government-owned lands in the West, they often do recognize state authority.

"We should pair increased funding for state-based programs with increased authority for states to manage public lands," Murkowski said, "and we should consider giving governors a say on federal land acquisition."

Other provisions in the bill include preventing the closure of federal lands for more than six months, reducing red tape for film crews and requiring the Bureau of Land Management and the Forest Service to take public comment on all potential closures of their lands. Currently, those two agencies do not have to hear from the public before closing federal lands to recreational use.

Mike Leonard, the ocean resource policy director at the American Sportfishing Association, said the legislation also takes the step of redirecting funds in the Land and Water Conservation Fund from land purchases to conservation.

He said the bill would be a formal signal from Congress to the Obama administration that hunters and anglers should be prioritized when it comes to running federal lands. Many hunters and anglers also would be happy to have a more stable habitat for the game they hunt and fish.

"It really improves access for hunters and anglers, and makes sure they have clean and healthy fish and wildlife resources to go after," he said.

The bill also would prevent the Environmental Protection Agency from banning lead fishing tackle, which is a top priority for Leonard's organization.

Instead, the measure would leave it up to the states to make decisions about whether lead tackle, commonly used in sinkers, lures and other baits, needs to be banned.

"It's a natural resource issue and where there are localized issues from discarded tackle, that should be a local issue," he said.

The Sportsmen's Act has appeared in various forms for the last five years, but supporters are hoping there's enough positive momentum to push it through Congress this year.

Senate Democrats have previously blocked similar legislation by attaching gun-control legislation to it, which Senate Republicans found unpalatable when they were in the minority. In 2012, the legislation died because one provision would have caused new spending, which Senate Republicans blocked.

The bill is being considered by the Senate Environment and Public Works Committee, which has jurisdiction over certain provisions in the bill. Democrats on the committee, who include some of the most environmentalist senators in the party, may move to block the bill again. A spokesman for committee Democrats declined to discuss which portions of the bill could be at issue.

The Democrats and Republicans on the committee are at odds on some pieces of the bill but are trying to work out their differences before a hearing on the measure, according to a committee aide.

A Republican Senate might give this iteration of the Sportsmen's Act a better chance. Mike Tadeo, a spokesman for the Republicans on the Senate Energy and Natural Resources Committee, said they feel there's more of a positive feeling around the legislation this time.

"[Murkowski] has spent a lot of time trying to educate her colleagues about it and it passed out of the committee with a bipartisan majority," he said.

President Teddy Roosevelt started the first official beginning of "preserving" scenic wonders on a national level; but have we now gone too far? ❖
